SECTION 4 – SAFETY AND WELFARE – FOR YOUR INFORMATION

We want to work in partnership with you to keep your child safe. These are the steps we will take:

1. We will make sure that all staff and volunteers who work directly with your children have satisfactory Disclosure and Barring Service (DBS) checks.
2. We will ensure our premises and equipment are safe.
3. We will provide adequate supervision for activities.
4. We will record any accidents or injuries your child may receive at the school and we will inform you about them as soon as possible.
5. If there is any suspicion that your child is in danger from a staff member or volunteer at the school, we will protect your child while we investigate the situation and we will keep you informed.



6. If we have any reason to be concerned about your child or if your child comes to the school with an injury, we will talk with you and/or your child about this, and if necessary, we will make a referral to Social Services.
7. We will encourage your child to speak freely about any concerns, or any aspect of the school that makes them unhappy, and we will try to put things right.
8. We will always make time to listen to you if you have any concerns about your child's safety and welfare or any aspect of the school.
9. A qualified Level 4 Forest School Leader, with First Aid training will be present on-site.

SECTION 4 - DATA PROTECTION

All data collected and stored by Woodland Adventure Harrow, is done so in accordance with the General Data Protection Regulations GDPR. The data is used to ensure the health and safety of children during sessions and stored securely online.
